Pricina

The pricing in this document aligns to the 24-25 National Disability Insurance Scheme (NDIS) Pricing Arrangements and Price Limits. Pricing is subject to change as per NDIS and/or Bedford updates in line with Bedford's Service Agreement. Remote prices will be applied in remote regions and reflected in Schedules of Support. Non-face-to-face, centre capital costs, transport and activity-based transport charges apply as per each client's Schedule of Support and Bedford's Terms and Conditions. Clients may be required to pay for out-of-pocket expenses for some programs, i.e., cooking class, public transport costs, etc. Notice periods and cancellation rules are as per Bedford's Service Agreement and Terms and Conditions.

Invoicing

Bedford will send invoices directly to your plan manager or you or your nominated representative if self-managed. Bedford will submit payment claims to the National Disability Insurance Agency (NDIA) if you are agency managed.

| the time and resources | This fee applies to new clients who receive at least 20 hours of personal care, community access or employment support per month for at least 3 consecutive months. This payment is a once off fee to cover the time and resources invested in ensuring Bedford can deliver high quality, personalised support that meet the unique needs of each client. The line-item name is called 'Establishment Fee Personal Care/Participation'. Below we have included the names of Bedford's services that match each code. Transport

Transport may be charged at different pricing levels based on the vehicle type. This charge covers vehicle running costs including fuel, maintenance, and insurance. A specialised or larger vehicle, such as a bus or a vehicle with wheelchair access, have higher rates due to the additional costs involved in operating and maintaining the vehicles.
